WHAT DOES BOWATER EMPLOYEES CREDIT UNION DO WITH YOUR PERSONAL INFORMATION?

WHY?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

WHAT?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number
- Account balances and payment history
- Credit history and credit scores

HOW?

All financial companies need to share members' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their members' personal information; the reasons Bowater Employees Credit Union chooses to share; and whether you can limit this sharing.

WHO WE ARE

How does Bowater Employees Credit Union protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law.
These measures include computer safeguards and secured files and buildings.

How does Bowater Employees Credit Union collect my personal information?

We collect your personal information, for example, when you

- Open and account or deposit money
- Pay your bills or apply for a loan
- Use your credit or debit card

We also collect your personal information from others, such as credit bureaus or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes-information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

DEFINITIONS

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- Bowater Employees Credit Union has no affiliates

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- Bowater Employees Credit Union jointly markets with CUNA Mutual Group, a company that provides insurance to credit union members nationwide.

OTHER IMPORTANT INFORMATION

When you browse our public web site at www.bowaterecu.org, you do so anonymously. We do not gather user-specific information. We use browser cookies to track user sessions in order to evaluate web site effectiveness and facilitate the use of our site. Our web site may contain links to other sites. The privacy policy at these sites may be different from ours. You should review the privacy policy of these sites before providing any personal information. Bowater Employees Credit Union will never ask you to follow a link and provide personal information.

When you log on to our secure online banking site and complete enhanced authentication, a cookie is used for authentication purposes and remains until you unregister your computer. Caution: When you open an email link from our website, information you send us is not encrypted nor secure. Only messages sent within the secure message link within online banking and the chat box on the Bowater Credit Union website are secure and encrypted.
